

PLAN COMMISSION NEWS – SURVEY OF TOWN RESIDENTS

It's been six-years since the Town of Mitchell last asked its residents their beliefs on how the Town should develop. At that time, residents said they wanted the Town to remain a rural, agricultural community; grow at a slower rate than was occurring then; increase the minimum lot size in the Town (it was then 1-acre, it's now 3-acres); and remain a single family residential community that relies on individual on-site sewage disposal systems (no sentiment for clustering of development on a larger parcel or forming small sanitary districts to serve areas of concentrated development).

So what do residents believe now?

You'll soon have your chance to tell the Town how you believe the Town should develop in the future.

In early January, the Plan Commission will mail out surveys to all residential addresses in the Town. The survey will ask questions on housing development, transportation, agricultural, natural resources, cultural resources, public facilities and utilities, economic development, land use, and inter-governmental cooperation issues. The Plan Commission will then use your responses in preparing a Smart Growth plan for the Town.

Please look for, complete, and return your questionnaire as soon as possible.

road. They also require pre-approval by the Town Road Commissioner for all driveways (the Town Chairperson is the Town Road Commissioner).

Driveways, at a minimum, are to have a surface that can be driven under all weather conditions and be at least 12-feet in width.

They must also have a clear-area of at least 24-feet in width and 14-feet in height that has no shrubs, bushes, trees, rocks, or similar intruding on it.

Culverts, at a minimum, must be made of metal or concrete and must be at least 24-feet in length and 15-inches in diameter.

So before you install a new driveway or arrange to have a new home constructed, call Chip Beckford, Town Road Commissioner at 528-8692, for approval of the driveway's location and culvert's size and placement.

TOWN POSTING LOCATIONS

The Town Board expects to change one of its 3 posting places – the one in the northeast part of the Town (currently at Johnson Wood Products on County N).

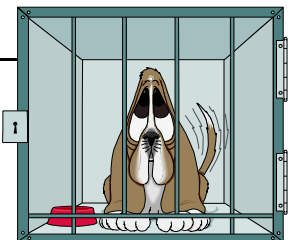
DRIVEWAYS AND CULVERTS

DOG LICENSING

It's that time again!

Time for you to license all dogs that you own or that you keep in the Town (whether you own them or not).



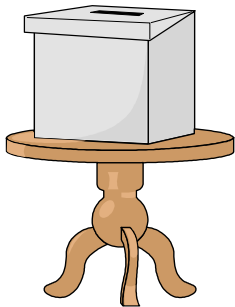
By law all dog licenses run from January 1st through December 31st each year but gives you until April 1st to license
REMEMBER:

- all dogs that are 5 months or older must be licensed each year;
- all dogs must show proof that they have been vaccinated against rabies before a dog license is issued to them;
- dogs that are less than 5 months of age on April 1st this year (or when they are first brought into the Town) must be licensed when they become 5 months of age;
- the fee for licensing spayed or neutered dogs is \$3 and for un-neutered or un-spayed dogs \$8;
- a \$5 late fee per dog will be charged for any dogs that are licensed after April 1st if they were old enough to be licensed by April 1st.

BUILDING PERMITS -- AFTER 1-YEAR . . .

Town of Mitchell building permits are good for 1-year from the date of issuance.

Town issued UDC (state uniform dwelling code) permits for the construction of new 1- or 2-family homes are good for 2-years from the date of issuance.

Both types of permits can be renewed for another year at half the original cost.

VOTING NEWS

54% Turnout

54% of the Town's residents who are over 18-years of age came out on November 5th to vote, a total of 476 votes. This turn-out rate is up from the 49% for the 1994 gubernatorial election but down from the 60% for the 1998 gubernatorial and the 70% and 84% for the 1996 and 2000 presidential elections. Not too bad; we did better than the average for the rest of the state, where the turnout rate was 44%.

Our State legislators are now Dan LeMahieu, Representative, 59th Assembly District and Mary Panzer, Senator, 20th Senatorial District.

There is only one set of elections next year – the Spring, non-partisan, election. Locally, we will be electing all five town officers (Town Chairperson, 2 Supervisors, Clerk, and Treasurer) as well as school board members. Statewide one supreme court judge is up for election.

The Election will be held on Tuesday, April 1st and the polls at the Town Hall will be open from 9:00 a.m. to 8:00 p.m. Should there need to be a Primary for any of the offices, it will be held on Tuesday, February 18th with the same poll hours.



PAIL & SHOVEL PARTY

The Town Board realizes there are times when sidewalks get very icy and a small amount of sand is needed by residents. To meet this need the Board, again this winter, has arranged to have a supply of sand available at the old town dump for town residents' use (the old dump is on the north side of Parnell Road just east of the Town Park, about a quarter mile east of the intersection of Parnell Road with County Roads A & V).

PLEASE, use only pails and shovels to load and remove the sand from the pile. Remember, if your sidewalk is icy, other residents' sidewalks are too.

RECYCLING NEWS

All residents of the Town are eligible for curbside collection of trash and recyclable materials. The monthly cost to residents is \$8.50 per address using the service. The annual cost to the Town is \$12,420 (or about \$28.00 per residence in the Town). The Town contracts for

this service with J. D. Trucking of Waldo. Trash and recyclables are picked up every two weeks on either a Thursday or Friday depending on which part of Town you live in. If you are not now having J. D. Trucking pick up your trash and recyclables and would like to, please call the Town Clerk at (920) 528-7776.

J. D. Trucking requires we use clear plastic bags for all trash or recyclable items. Use of the clear bags makes it easier for J. D.'s employees to put the trash and recyclables into the proper trucks and to make sure there are no recyclables in with the trash. The State may inspect any loads of trash going to a landfill to see if there are any recyclable materials in with the trash. If the State finds any, they will fine the hauler and require the hauler to sort through the load to remove any recyclable materials from the trash.

What recyclable items will J. D. Trucking pick up?

- Class 1 and 2 plastics (food grade plastics) with caps removed and rinsed out;
- Glass jars and bottles, whether clear or colored, with caps removed and rinsed out;
- Metal cans, both aluminum and tin and steel food cans, that have been rinsed out;
- Newspapers and newsprint which are bundled and tied;
- Glossy print materials such a magazines which are bundled and tied; and
- Corrugated cardboard boxes (not cereal or other flat cardboard boxes) which are flattened, bundled, and tied.

In addition to the curbside pickup, between the months of March and October, the Town has arranged with J. D. Trucking to be at the Town Hall on the last Saturday of the month, to pickup metal and old appliances (except those containing Freon, such as refrigerators, air conditions, dehumidifies, etc.). Although none of the following can be put out for pickup, for a fee you may bring them to J. D. Trucking's facilities in Waldo for disposal – old iron, couches, mattresses,

televisions, tires, oil, batteries, and construction or remodeling debris (roofing, siding, plaster,

drywall, scrap lumber, etc.).

ALL DOGS MUST BE LICENSED AND VACCINATED

Landlords – Please inform your renters !

At time of licensing, give breed, sex, name, and color of dog; and bring or send proof of rabies vaccination. Mail-ins are allowed, if records are provided BUT you must include a stamped, self-addressed envelope for return of the license(s). Costs are as follows:

Unneutered male or Unspayed female \$ 8.00 Neutered male or Spayed female \$ 3.00
Kennel license \$35.00 for up to 12 dogs PLUS \$3.00 for each additional dog

Late Fee \$5.00 per dog if licensed after April 1, 2003
