2. **NOTICE IS HEREBY GIVEN** that the Plan Commission will have a Public Hearing on January 30, 2017 beginning at 7 p.m., located at the Town Hall, W8095 Parnell Road, Cascade, WI 53011, to consider the request from Robert Luedtke/B & P of Hortonville, LLC for a conditional use permit. Robert Luedtke/B & P of Hortonville, LLC is the owner of the Tax Parcel 59012156263 Property address is located at W7295 County Road N Plymouth, WI. Legal Description: Part of the NW NW, SEC 13 T14 R20 Town of Mitchell, Sheboygan County, Wisconsin. Reasons & justifications for the public hearing: Robert Luedtke/B & P of Hortonville, LLC proposed use and operation of the property includes automotive vehicle repair, milk trucking business, and minimum amount of storage of auto trailers and general storage.
  - Barb Crosser discusses the location of the septic tank which is located east of the small brick house next to the property and the septic field is in lot 2 per the County's records. Also, she would like the hours of operation to be clarified for the building as well as future employees beyond family members.
